4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 7(a) from **10:00 a.m. – 4:00 p.m. on weekdays except public holidays**.

The bidding document which has been prepared in English language may be purchased by interested bidders at 7(b) upon **submission of a written application and payment of a non-refundable fee of UGX 100,000 (Uganda Shillings: One Hundred Thousand) only**. 
opening. The Fund will open bids and results of the bid opening shall be sent to all participating bidders.
